

## Current situation

NT Airports is continuing to monitor the COVID-19 situation. Our priority remains the wellbeing and safety of our staff, contractors, visitors and travellers.

We are actively improving our airport facilities and procedures to ensure our people are protected and to enable appropriate social distancing and hygiene.

NT Airports welcomes the announcement from the Northern Territory Government's to reopen domestic borders on 17 July.

We are looking forward to an increase in visitors to the Territory with the introduction of more flights and changes to mandatory quarantine requirements. Tourism is critical to the economic wellbeing of the territory and this first step will provide much needed support for this industry.

## Latest advice

As of Thursday 2 July, there is one active case of COVID-19 in the Northern Territory. It is important that we continue to follow the recommended health and travel advice and avoid becoming complacent.

## Airport operations

Alice Springs Airport has reduced operating hours and there is restricted access to the terminal. There is a maximum of two people allowed at reception at any time. Operating hours will continue to be reviewed each week in line with flight schedules.

Non-stop services to all major interstate cities including Brisbane, Sydney, Melbourne, Adelaide and Perth will start to resume from Alice Springs Airport. Alice Springs Airport also welcome back Virgin Australia which will recommence its operations to Central Australia Monday 20 July.

It is important that we continue to adhere to mandatory work health and safety requirements, particularly the Airside PPE Policy. ## Changes to restrictions

From Monday 15 June, the Northern Territory transitioned from mandatory, monitored quarantine to mandatory, self-quarantine. People arriving into the Territory are able to undertake the 14 day quarantine period in their own home as long as they meet the appropriate guidelines.

People arriving from overseas are still required to undertake the 14 day quarantine period in mandatory accommodation at their own cost.
